It was commented that the dog bin in Wickerstreet Green is being very well used and is filled on a regular basis. It perhaps needs to be included in the Babergh dog bin scheme. The Clerk will get a quote and this will be included on the agenda for the next meeting.

Concern was raised about traffic speeding through Wickerstreet Green. A Councillor is going to seek information about speed indicators from Robert Lindsay.

The Chair has been in touch with the new tenants at The Bell who have indicated they are willing to join in with the Jubilee celebrations.

Councillors have been working with the parking expert on communications and education information, this will be circulated to all Councillors shortly.
