Proposal: Application to determine if prior approval is required for a proposed: Erection, extension or alteration of a building for agricultural or forestry use. Town and Country Planning (General Permitted Development) (England) Order 2015 (as amended) Schedule 2, Part 6 - Erection of steel framed agricultural storage building

The Chair explained that since this application was for permitted development the application under consideration was to determine if prior approval was required.

The Clerk withdrew from the meeting because the application was made by her family.

The applicant was present and explained that the proposed building was for additional storage. This will reduce waste and travel between farms as more feed can be stored in the dry on site. The new building will be adjacent to existing buildings. The size and scale of the proposed storage building is similar to other buildings in the farmyard.

The Parish Council considered this application, and resolved by a unanimous decision to support this proposal and therefore determined that prior approval was not necessary.
